MEN AS CHAMPIONS OF CHILDBIRTH **SPACING IN KANO STATE: PROMOTING** THE HEALTH OF WOMEN

(Dialogue with Men)



BACKGROUND

The birth of a baby in every home is a thing of joy; however, women approach childbirth with apprehension because many pregnant women die from preventable pregnancy related

complications. In Nigeria, 1 out of every 13 pregnant women is of dying risk complication that could occur during pregnancy, at delivery or immediately after birth. Regional (North West zone to Kano state belong) which maternal mortality ratio is estimated at 1,025/100,000 live birth. The high maternal mortalities not are only tragedies in themselves, they represent enormous loss to families, communities and the nation.

As at 2017, Kano State has an estimated population of 13,534,125 people, and 2,977,508 women of reproductive age, with growth rate estimated at 3.3% (NPopC, 2006 Census projected by NBS 2018).

However, the population growth rate may be much higher now, due to the influx of Internally Displaced Persons (IDPs) from Yobe and Borno States, due to the insurgency in the North-East of Nigeria. Kano State has about 1,508 Health Facilities (1,257 Public and 251 Private) with about 822 Public Health facilities providing childbirth spacing services.

The good news is that this

maternal death in Kano State could be prevented simply by learning more about healthy timing and spacing of pregnancies and taking action to access quality information and services.

DESIRE TO USE CBS

- ▶ In Kano State, about 36 percent of women in Kano State desire to space pregnancy. This means that on average, 1 out of 3 women, representing 747,794 out of a population of 2,077,207 women of reproductive age desire to space childbirth (NPC & IMC Macro, 2014). However, most of these women are unable to access the childbirth spacing (CBS) services without the support of their husbands.
- ▶ The Kano State Government is committed to improving the health of women, families and communities. To this end, the Government is upgrading facilities and introducing contributory health insurance scheme, and facilitating access to quality, client responsive childbirth spacing services.

WHY MEN SHOULD BECOME CHAMPIONS **OF CHILDBIRTH SPACING**

MEN have traditionally determined household decisions, including access to health care and childbirth spacing services. When men are knowledgeable about the benefits of childbirth spacing, they support and prioritize women's health and avoid the tragedy of maternal death by practicing healthy timing and spacing of births (Formative data: Findings from health facility and flex-track surveys in Kano State, June 2018).

MEN therefore bear the responsibility of reducing maternal death. The good thing is that men can achieve this by learning about the benefits of child birth spacing services, and the consequences of denying women the opportunity to space childbirth.



ACTIONS REQUIRED

- Know the facts about childbirth spacing.
- Talk about it with your wives/partners, peers and experts.
- ▶ Encourage and use suitable methods of childbirth spacing by accessing services available near you from qualified providers.

BENEFITS

- ▶ Reduction of maternal mortality by 40% through childbirth spacing is possible and this promotes maternal health and family wellbeing.
- ▶ Resources will also be freed up for other investments which would otherwise be spent as a cost of care.

The good news is that this maternal death and disabilities in Kano State could be prevented with cost effective, comprehensive and integrated health awareness campaigns that highlights the benefits of investing in childbirth spacing with clear messages to policy makers, health managers and beneficiaries (community and religious leaders, families and women).

ACTIONS REQUIRED

- Calling for appropriate budgetary allocation and releases for the provision of quality childbirth spacing services and strategic behavior change communication campaign.
- ▶ Investigating how programs respond to the needs of the people, determining the availability and access to services, quality of service, distributive equity as well as whether people are using the services provided or not and why not.
- ▶ Initiating programs, editorials and experts on the benefits of healthy timing and spacing of pregnancies and births, including the consequences of non-use of modern methods of childbirth spacing.

BENEFITS

- ► Reduction of maternal mortality by 35 40% through childbirth spacing is possible and this promotes maternal health and family wellbeing.
- ▶ Resources will also be freed up for other investments/capital projects which would otherwise be spent as cost of care.
- ▶ If Kano State achieves its Costed Implementation Plan (CIP) goal of 17% mCPR, the State could save a total of 4.5 Billion Naira in costs of maternal and child health care. For this to happen, Kano State would need to budget more funds for child brith spacing (CBS) services.

IMPROVED CHILDBIRTH SPACING FUNDING MECHANISM

(Role of the Legislature)

- 1. Primary Health Care Under One Roof
- 2. Kano State Contributory Health Care Management Agency
- 3. Task Shifting and Task Sharing Policy
- 4. Basic Healthcare Provision Fund, and
- 5. Other social interventions that may be considered in future

ACTIONS REQUIRED

- ▶ Make the appropriate budgetary provision for childbirth spacing services and ensure cash backing and release.
 - Use the Kano State Childbirth Spacing Costed Implementation Plan (CIP) as a guide to the funding needs of the State annual budgetary provisions.
- Prioritize childbirth spacing intervention as a development agenda for Kano State.

BENEFITS

- ▶ Resources will also be freed up for other investments/capital projects which would otherwise be spent as cost of care.
